

**48th ANPAD Annual Meeting – EnANPAD 2024 - CALL 06/2024**  
**CALL FOR SUBMISSION OF DIVISIONAL AND INTERDIVISIONAL ACTIVITIES AT ANPAD'S ANNUAL MEETING**

**Reimagining the Role of Organizations in a World of Geopolitical Tensions, Social Inequality, and Environmental Crisis**

**1. OBJECTIVES**

- 1.1 Receive innovative proposals for activities to be included in the official EnANPAD 2024 program;
- 1.2 Encourage proposals for Interdivisional or Divisional activities, seeking to consolidate national and international collaboration;
- 1.3 Gather debates that corroborate the central theme of EnANPAD 2024. Other activities of general interest to the community may also be accepted;
- 1.4 The submission of activities that promote integration between academia and representatives of different sectors of the economy/market/public bodies/government is encouraged;
- 1.5 Promote transversal debates that integrate national and international research and researchers with the conference's general theme;
- 1.6 Provide opportunities for discussion of topics associated with established research groups;
- 1.7 Promote the discussion of emerging and cutting edge themes in the area/academic division and the conference theme; and
- 1.8 Offer younger researchers the opportunity to participate in discussions with experienced researchers.

**2. CONTENT OF THE ACTIVITY PROPOSAL**

- 2.1. Activity title
- 2.2. Format:
  - 2.2.1. Applicant (only one person);
  - 2.2.2. Participants (minimum three and maximum five people).
- 2.3. Justification of the activity theme: up to 4000 characters;
- 2.4. Suggestion and justification of the presentation model: up to 800 characters;
- 2.5. Activity language: Portuguese, Spanish or English.
- 2.6. Link to the applicant's and participants' CV Lattes or Curriculum Vitae.

### **3. FORMAT AND ACTIVITIES PROPOSED**

#### 3.1. Participants:

3.1.1. Researchers with solid academic careers in the theme of the conference or proposed activity (or Division and interest groups) in Brazil and internationally. This item will be assessed through the CV Lattes or Curriculum Vitae.

3.1.2. A minimum of three and a maximum of five participants – preferably from at least three different higher education institutions (HEI)s, from at least two different Brazilian states.

3.1.3. Members of ANPAD's board of directors, Chairs of Divisions, and those related to ANPAD's Scientific Committee cannot participate as activity participants.

3.2. Each activity will have a maximum duration of 105 minutes.

3.3. The number of activities approved will be submitted to planning carried out by ANPAD's Scientific Director and will be accommodated according to the conference's structure.

### **4. EVALUATION**

#### 4.1. Evaluators:

4.1.1. Scientific Director, Scientific Committee, and Chair of Divisions (for divisional proposals).

4.1.2. ANPAD's board of directors (for interdivisional proposals).

#### 4.2. Criteria:

4.2.1. Contribution to EnANPAD's central theme; and

4.2.2. Contributions to the debate on the evolution of EnANPAD's knowledge.

### **5. SUBMISSION AND PRESENTATION OF ACTIVITIES**

5.1. Activities will be submitted to a single Division and Interest Group or as an interdivisional activity. In case of duplication, the oldest submission will be excluded;

5.2. Participants may submit one activity proposal. The system blocks multiple participation;

- 5.3. All applicants and participants must have an iANPAD registration and register for the conference;
- 5.4. Non-registration of any applicant or participant of selected activities will result in the exclusion of the activity in the conference schedule and the prohibition, for one year, of proposing activities in ANPAD meetings.
